**NOTICE OF ACCEPTANCE OF RESIGNATIONS AND DISSOLUTION OF
UNSECURED CREDITORS' COMMITTEE**

The United States Trustee for Region 19, by and through his attorney, Laurie A. Cayton, hereby provides notice of the Acceptance of the Resignations of members of the Official Unsecured Creditors' Committee ("the Committee") and the dissolution of the Committee. In support hereof, the United States Trustee states as follows:

1. The Chapter 11 case of The Falls Event Center LLC was filed on July 11, 2018.
2. On July 27, 2018, the United States Trustee filed a Notice of Appointment of Unsecured Creditors' Committee, reflecting the appointment of the following persons or entities to the Committee:

Bruce Johnson;
Robbie Mathews;
Woody Filippi;
Michael Sanderson;
Brent Pulley;

3. On November 1, 2018, the United States Trustee, Debtor and Unsecured Creditors' Committee filed a Stipulated Motion to Appoint a Trustee. On November 14, 2018, the Court entered an order granting the Motion to Appoint a Trustee. On November 27, 2018, the Court entered an Order approving the appointment of Michael Thomson as the Chapter 11 Trustee.
4. On April 22, 2019, this case was substantively consolidated with the case of The Falls at Clovis - 18-28140, The Falls at Fresno - 18-27713, The Falls at Gilbert - 18-25419, The Falls at McMinnville - 18-25492, The Falls at St. George - 18-26653, and The Falls of Littleton - 18-27111
5. Since the appointment of the Chapter 11 Trustee and the consolidation of the cases,

- the United States Trustee and the Chapter 11 Trustee have reviewed the continued need, benefit and cost of the Committee. The United States Trustee has communicated with counsel for the Committee regarding the continued need, benefit and costs of the Committee.
6. Following these communications, all members of the Committee have resigned from the Committee.
 7. The Chapter 11 Trustee and the Committee have communicated to the United States Trustee their position that continued operation of the Committee is not necessary to the effective administration of the estate, would not be likely to bring significant value to the estate, and would create additional unnecessary costs of administration. The United States Trustee concurs in these conclusions.
 8. For the reasons set forth above, the United States Trustee accepts the resignations of the Committee members as set forth above and dissolves the Committee. For the reasons set forth above, reconstitution of the Committee or the creation of further official committees in this case is not appropriate at this time.
